#### **Central Magnet School PTO Fundraising, 2018-19 Final Report**

#### Overview

The PTO's purpose is to provide resources to enhance the education of students and supplement the needs of teachers and students. All parents/guardians of CMS students plus teachers and administrators are members of the CMS PTO. This report details the fundraising component of our purpose.

In the 2018-19 school year, Central Magnet School families and community supporters donated \$83,137.52 to CMS through the three PTO fundraisers: AmazonSmile, "An Investment for a Brighter Future" Campaign, and Super Trivia Bowl VIII. PTO members voted to return these funds directly to the school on September 20, 2018 (\$37,000), March 4, 2019 (\$38,000), and May 24, 2019 (\$6,000).
